**Special Note:** Professional clinical competency courses must be taken at TWU in the Department of Family Sciences. The student must take these courses in sequence and earn a grade of “CR” in each course to advance in the sequence. Any student receiving a “PR” in one of these courses must retake the course before progressing in the sequence. Students receiving 1 (one) “PR” in a professional competency course must meet with the Counseling and Development faculty before registering for additional courses. Students receiving a “C” in any course must meet with the Counseling and Development faculty before registering for any additional classes. Two grades of “C” or “PR” will result in dismissal from the Counseling and Development program.

Students wanting to register for the five professional competency courses (Prepracticum, Group, Practicum, and Internship) need to fill out an application for admission for **each** restricted enrollment course. Students will be informed by letter when they are admitted to the class. Applications for restricted enrollment courses need to be completed one semester prior to enrollment. The application forms are available on the forms rack outside the Family Sciences office.
