Welcome back for the fall 1994 semester -- particularly to new faculty and staff who join TWU during a busy and exciting time...a new president, new students, different projects, a new legislative session and many other challenges that will face the campus community during the 1994-95 academic year. A "quick list" of facts, deadlines and other information is provided below to make the beginning of this new year run as smoothly as possible:

■ Dr. Carol Surles, who was selected by the TWU Board of Regents in May as the university's ninth president, began her tenure on Aug. 15.

■ All offices return to a five-day work week, Monday through Friday, 8 a.m. to 5 p.m., effective today. (Hours for the Information Booth are: Monday through Thursday -- 7:30 a.m. to 9 p.m.; Friday -- 7:30 a.m. to 4:30 p.m.; Saturday -- 8 a.m. to 1 p.m.; Sunday -- closed.)

■ Fall assembly is scheduled today at 10 a.m. in the auditorium of the Multipurpose Classroom Laboratory Building. Surles will deliver her first formal address to the faculty, looking ahead to a new administration, academic year and issues that faculty, staff, students and the community will face during the coming months. Dr. Wilkes Berry also will provide a special program that attendees will enjoy.

■ New faculty orientation is Wed., Aug. 24, from 8:30 a.m. to 4:30 p.m. on Guinn Commons. Departmental and college meetings are scheduled by chairs and deans; consult your specific area for dates and times.

■ Payment settlement is scheduled this week on Thursday, Friday and Saturday; late payment begins on Mon., Aug. 29.

■ Parking decals for the 1993-94 academic year expire on Aug. 31; the department of public safety will begin writing tickets Sept. 1 for vehicles with expired stickers or no stickers. Parking stickers are available through the department of public safety weekdays from 8 a.m. to 5 p.m. in their offices at 1215 Oakland Ave.

TWU FACULTY EARN GRANTS

Several faculty members from Texas Woman's University recently received federal and private grants for research projects in nursing, kinesiology and physical therapy, according to Dr. Sondra Ferstl (research and grants) at TWU. Descriptions of each grant are listed below.

■ Dr. Judith McFarlane (Nursing--Houston) has received a \$124,777 grant from the University of Virginia as part of a flow-through project from the Centers for Disease Control and Prevention. Her project, titled "Preventing Abuse to Women," is funded from June 1, 1994, through May 31, 1995.

"This research aims to evaluate the effectiveness of an intervention protocol for abuse in public and private emergency departments with an ethnically stratified group of abused pregnant women," explained McFarlane. Two groups of 60 women each who report abuse in the year prior to presenting themselves at the emergency department and who are diagnosed with threatened abortion (TA) will be followed for 18 months. Each group will comprise 20 African Americans, 20 non-Hispanic Anglo Americans and 20 Hispanic women. "Abused women will be randomly assigned into one or two groups to measure the effectiveness of the intervention," she added.

■ Dr. Charlotte Sanborn (kinesiology), director of the TWU Center for Research on Women's Health, has been awarded a federal grant from the National Institutes of Health-AREA Grant for her research, "Resistance Training and Bone Density in Adolescent Females." The \$95,699 award has been funded from July 1994 through July 9, 1997.

"We will investigate the influence of resistance training in adolescent females with the goal of optimizing peak bone density," said Sanborn. Sedentary females -- those who engage in less than an hour of physical activity each week -- between the ages of 15 and 17 will be chosen for the study; several other criteria will be used in the selection process. The specific aims of the project are: to determine the impact of a 15-month resistance exercise intervention on lumbar bone density; to examine the effectiveness of this exercise intervention on total bone density; and to determine the effects of resistance training on bone formation and resorption in adolescent females.

■ Raymond McKenna, a doctoral student in physical therapy at the Houston Center, has received a \$5,000 private grant from the Foundation for Physical Therapy. His research project,

"Validation of a Computer Program for Modeling a Reach Task in Patients with Shoulder Pathology," has been funded from July 1, 1994, through June 30, 1995.

The purpose of the study is to compare the actual motion of a reach task performed by a subject with shoulder pathology to the simulated motion created by the JACK software package. "The JACK environment is a computer program used to model humans for anthropometrics, strength and motion," said McKenna. "This research will investigate the accuracy of the software to model an abnormal reach task motion secondary to shoulder pathology."

MCL BUILDING CONVERTED TO LOCKING SYSTEM

The lock system in TWU's MCL Building was recently converted Aug. 15-19; the changeover requires all individuals who are authorized to have keys for that building and its offices to obtain new keys. New keys not acquired before Aug. 24 can be picked up beginning Sept. 1. (Keys will not be issued Aug. 24-31 because of payment settlement.)

Faculty and staff who have a key that is covered by a key request and deposit may obtain a new key without additional paperwork or deposit. Those who do not have a key deposit on file must have a signed key request form and make a \$5 deposit with the department of public safety to receive a new key.

STUDENT HEALTH SERVICES ASKS FOR HELP

TWU student health services reminds all departments that, when they sponsor guest conferences on campus, they need to coordinate with the health service if medical care will be extended to guests -- especially minor children. "This summer, a number of minor guests (under age 18) have presented themselves to the TWU student health service for medical service without proper parental consent," said Dr. Linda Lekawski, director. "Medical care (for minors) cannot be provided without proper consent. The only exception to this standard is, of course, a life-threatening emergency. In any life-threatening situation, ext. 2911 should be dialed first to assure the quickest dispatch of emergency equipment and personnel to our campus."

Anyone interested in receiving a copy of the form that parents need to sign to give consent for treatment, should contact the TWU student health service at ext. 3826 or call Tana Kearns (conference services) at ext. 3642.

Also...TWU student health services will be sending a brochure titled "Seizure Recognition and First Aid" to all departments on campus from the Epilepsy Foundation of America. This distribution will be made in response to a request for information from TWU faculty members. "The TWU student health service is prepared to do class presentations or programs for campus organizations on a variety of health-related topics," said Lekawski. "Please call us if we may be of help to your department."

UPDATE FROM HUMAN RESOURCES

The TWU department of human resources has several reminders and items of information for university faculty and staff:

■ *Disabilities accommodations* -- Faculty and staff with disabilities may request accommodations by contacting the department of human resources. Students must contact the office of disability support services to request accommodations assistance; the TDD number for that office is ext. 3606.

■ *Temporary or on-call employees and graduate teaching assistants* -- Employees who are working as graduate teaching assistants or in temporary or on-call positions during the 1994-95 fiscal year must be reappointed for any portion of the appointment that extends beyond Aug. 31, 1994. Deans, directors and department heads should complete a personnel transaction form (PTF) to reappoint any employees who will continue to work in the categories listed above for 1994-95. PTFs should be submitted to the department of human resources *by Thurs., Sept. 1, 1994*, to ensure that these employees are included on the September payroll. ■ *Revised health premium cost for Sanus Texas Health Plan* -- On July 7, 1994, the state's Legislative Budget Board voted to limit the plan year 1995 maximum state contribution to the same level as the 1994 plan year maximums. As a result, this action will affect out-of-pocket costs for employees and retirees who will be enrolled in the Sanus Texas Health Plan/Dallas-Fort Worth. The changes are:

Anyone who is enrolled in Sanus and who wishes to change to another health plan because of the premium increase must submit the appropriate form that is required to change health plans; the form must be submitted to human resources by Aug. 31, 1994.

■ *Employee holiday schedule preparation* -- How is the number of holidays determined each year for employees at TWU? Carrie Stephens (human resources) says that state law in Texas lists 17 holidays from which institutions of higher education may develop a holiday schedule. Holidays may be scheduled at the university's discretion as long as the number of days does not exceed the number allowed by law. The number of holidays that may be scheduled is reduced by the number of days that fall on a Saturday or a Sunday. The number of days that remain after excluding Saturday and Sunday holidays may be scheduled according to the university's needs.

She adds that some of the holidays are standard and are specified as holidays in the state appropriations bills, such as the fourth Thursday in November, the fourth Friday in November, Dec. 24 and Dec. 25. The remaining holidays may be scheduled according to the institution's discretion. The employee holiday schedule is developed around the TWU academic schedule, as well as the Denton public schools' schedule, for spring break. "The fluctuation of the number of holidays from year to year depends on the calendar and how many specified holidays fall on Saturday or Sunday," says Stephens.
