Scott Martin: Lecture ours are 1 to 1 SCH equivalent. They are getting 1 hour for the 1 lecture hour. With lab hours you have to have a minimum of 2 lab hours to make 1 SCH. There is a range. They can do 2:4 lab hours to have 1 SCH credit. There's an overlap at each end so that the component can make the determination of whether to give a lower or higher SCH. There is a mathematical formula that drives it. Agatha Beins: SLO 6 looked like there may have been a typo, "correctly" instead of "correcting".

Questions/Comments/Concerns: Agatha Beins: Two questions regarding NURS 0 4142. There seemed to be only one explicit mention of a global focus. What needs to be explained to indicate a global focus? Why not do this with all courses? Joy: We split the global perspectives requirements. Nursing has undergone a massive shift in perspectives with nurses traveling to provide care in other places. We have had conversations about incorporating study abroad where we could send these students in this new curriculum to Mercy Ships. This would help extend that global focus. Scott Martin: If you elect to have an interactive component, you will have to revise the program. It has to be a practicum or clinical component in order for us to deal with the insurance aspect of it. Regarding the global perspectives component, there is a global perspectives core committee. Based on the information that is provided in the proposal, they do an evaluation to ensure that it meets the expectations of the state to designate it as a global perspectives course.
